Whereas **Settlers and Authors of the Trust** are possessed of and otherwise well and sufficiently entitled to the sum of **Rs. 25,000.00 (Rupees Twenty-Five thousand only)** hereinafter referred to as said property. Whereas the Author of the Trust desires to irrevocably endowing the said funds upon trust for public, educational, and cultural purposes, as hereinafter expressed and contained in this presents and in pursuance of such desire have already transferred, paid and handed over the said property to the trustees above mentioned.

1. NAME

The Trust hereby established shall be named as **MAA LAKSHMI FOUNDATION.**

2. PLACE

Office of the Trust shall be situated at 3/B, "Sukh- Sandhya" Sukhdeo Nagar, Churi – Center Gali, Ratu Road, Ranchi 834005 or at such other place or places in India as the Trustees may from **time to time think fit.**

3. OBJECTS

The objects for which the Trust is founded are:

- a) To establish, maintain and run Schools, Colleges, Social service centres Vocational Training centres, Industrial Training centres, computer hardware and software training centres, polytechnics, Teachers' Training Colleges, Law Colleges, colleges and institutions of higher & specialized learning to impart education especially in emerging field like Engineering & technology, Architecture, Medical Sciences, nursing, pharmacy, Business management, Agriculture, Rural Management, Horticulture, Ecology Electronics, Biotechnology, and other allied fields.
- b) To establish, Training Centre, and allied educational institutions and to takeover, affiliate, amalgamate or merge with any other trust, society, association institution, body or group of persons having objectives similar to the trust.
- c) To establish, assist, sponsor and promote Cultural and Social Institutions, camps for blood donation, eye testing/treatment, vaccinations immunizations and health check-ups.
- d) To spread for promotion of education, research and learning in all branches more specifically in modern liberal arts, Legal Studies and Science and Technology.
- e) To advance Indian Culture and Literature, Service of this Country for the benefit of our Nation.

- f) To train teachers and workers in ideals and practice of the true spirit of the education and learning.
- g) To establish research and training centres for the furtherance of education/learning in it's various fields and branches.
- h) To undertake propaganda, training and education of the masses either of its own or in co - operation with similar Agencies working for the cause of all round development of the Society.
- i) To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.
- j) To function as a Non-communal Trust and as a secular organization.
- k) To establish centres for employment generation.
- l) To acquire and maintain the movables and immovable properties owned/to be owned/acquired/ to be acquired by the Trust for achieving said objects.
- m) To advance any other objects of general public good, development and utility.
- n) To confer titles on and hold public felicitation of eminent personalities in the field of science, social work, sports, arts & culture, mass communication, entrepreneurship, charitable work, education, literature, etc.,
- o) To undertake welfare schemes for tribals and primitive tribes.
- p) To work towards enhancing general public awareness of health, hygiene, sustainable exploitation of natural resources, bio-diversity, abolishment of superstitious practices and for ending discrimination on account of caste, creed and religious beliefs.
- q) To organize relief work and/or donate funds and/or for providing relief materials, food and medicines during times of natural calamities, accidents, communal strife.
- r) To provide such help as considered appropriate towards helping orphans destitute women, tribal & primitive tribes and people

from the down-trodden sections of the society. To organize, establish, set up, found, support, assist arrange, promote, maintain and run centres and facilities for social development & justice and for poverty alleviation.

- s) To invest funds/monies of the trust as per the extant provisions of the appropriate Act of Law and in such a manner as to get optimum return thereon and to use such returns towards furthering the objectives of the trust.
- t) To give preference to wards of the employees in getting admission in the educational and vocational training institutions owned, run or managed by this trust.

The trust shall be an irrevocable public educational, cultural trust for the benefit of all persons belonging to whatever community irrespective of Caste, Creed or Religious belief. Trustees shall stand possessed of the said amount of corpus endowed by the Settlor and Author of the trust and such other funds and properties (both movable and immovable) as may be acquired from time to time by the Trust, by purchase lease exchange, grant, allotment, subscription, endowment, donation, contribution or in any manner to whatsoever (all of which shall be designed as Trust properties) on the Trust herein mentioned.

4. NUMBER OF TRUSTEES

The number of Trustees including the Settlor and Author of the Trustees shall not be less than 2 (two) and not more than 5 (five) persons. The Board of Trustees shall nominate and invite person/persons to be the other trustee for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES

These Trustees shall hold office for such duration as may be specified by the board of trustees.

6. CHAIRMAN

There shall be a chairman for the administration of this trust, nominated by the board of Trustees, who shall be one amongst

trustees as specified in para (4) above for such period, in such manner as may be specified in this behalf.

7. MANAGING TRUSTEE

- i. The day- today administration of the Trust shall be looked after by the Managing Trustee under the guidance, control and supervision of the Board of Trustees.
- ii. The Board of Trustees shall nominate one amongst the trustees as specified in para (4) above to be the Managing Trustee, who shall hold office for such period, as may be decided by the Board of Trustees.
- iii. The Managing Trustee shall perform all functions, discharge such duties as or specifically entrusted to him/her in writing by the Board of Trustees.
- iv. The trustees shall also be authorized to voluntarily constitute an advisory board or such advisory board headed by an Executive Advisor essentially from beyond the board of trustees for accessing requisite professional, organizational and managerial services, The trustees shall, however, maintain regular inter-face with such Advisory Board through the Executive Advisor to be appointed contractually from time to time who will submit reports to the trustees periodically and or as deemed appropriate by the trustees. The Executive Advisor may be supported by expert or a team of experts in a particular field of endeavour with the prior approval of the trustees.

8. VACANCIES

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in para (4) above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

9. TERMINATION OF OFFICE OF THE TRUSTEES

The office of a Trustee shall ipso facto become vacant on account of any or more of the following reasons:

- i) Death,
- ii) Resignation,
- iii) Insanity
- iv) If he is adjudged insolvent or found guilty of an offence involving an act of moral turpitude.
- v) If he is found to have acted against the interest of the Trust.
- vi) If it is unanimously decided by the Trustees specified in para (4) above that his continuation in the Office is against the interest of the Trust.
- vii) Upon expiry of the period up to which the Board of trustees have nominated the trustee.
- viii) Incapacitated to perform duties of a trustee for sickness or personal reasons.
- ix) Any trustee failing to attend 3 (three) consecutive meetings of the Board of the Trustees without assigning any proper reasons therefore, shall be deemed to have voluntarily vacated his position as a trustee unless the remaining trustees decide otherwise by majority votes and in case of such vacancy, the rest of the trustees shall proceed to nominate any other suitable persons or with the reduced number of trustees if so permitted by the Board of trustees.

10. MEETING AND PROCEEDINGS OF THE TRUSTEES

The Trustees shall ordinarily meet at least once in 3 (three) months or as often as may be necessary for the satisfactory conduct of the affairs of the Trust.

11. NOTICE

15 (fifteen) days Notice shall ordinarily be given in writing for meeting of Board of Trustees.

12. QUORUM

The Quorum for the Meeting of the Board of Trustees shall be 2 (two) numbers and quorum is required for a meeting or else the meeting shall be adjourned for want of Quorum.

A minute book shall be kept by the Managing Trustees Minutes of entry into the office of every new trustee and of all proceedings of the meeting of the board of trustee shall be entered in the minute book and shall be signed by the President of the Meeting.

13. VOTING

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the board of Trustees present at the Meeting. The President of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

14. POWERS, FUNCTIONS AND DUTIES OF THE TRUSTEES

All property of the Trust Movable or Immovable or of any other kind, shall vest in trust, the trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion and carrying out of the objects of the trust.

In particular and without prejudice to the generality of the foregoing the trustees shall for the purposes of this trust have the following powers, duties and functions;

- (1) To acquire by Gift, Grant, Purchase, Exchange, Lease, or otherwise, lands, buildings, or other immovable properties and also any movable Property.
- (2) To construct and maintain building to alter, modify, extend, demolish or improve them and equip them suitably.
- (3) To accept monetary gifts, donations, endowment and contributions for and on behalf of the Trust in Indian Currency and/or Foreign Exchange and this shall be treated as the income of the Trust.

- a) To raise loans, to mortgage/hypothecate the trust properties for raising loans from banks and financial institutions or private lenders, to receive monies, securities or other movable property on behalf of the Trust.
- b) To accept any trust, trust fund or endowment so long as the provisions of such Trust or endowment are in consonance with the objects of this Trust.
- c) To award scholarship and make donations calculated to promote the objects of the Trust.

(5)

- a) To enter into contracts, or engagements on behalf of the Trust.
- b) To consider such proposals submitted by Sub -committee appointed by this trust and allocate such funds, if necessary, as deemed necessary for the implementation of the programs.

(6) To make, sign and execute all such documents instruments, as may be necessary or proper for carrying on the management of the properties and affairs of the Trust.

(7) To invest such monies and such funds of the trust and to vary the investment as and when it may seem necessary or proper provided that such investments shall be made only upon immovable properties or upon securities as the board of trustee may deem fit, under section 20 of the Indian Trust Act, 1882.

(8) To sell, transfer or otherwise dispose of any immovable property of the trust provided all the trustees unanimously resolve that it is in the interest of the trust to do so to sell or lease, mortgage or otherwise dispose of any movable and immovable properties of the Trust. All and any funds/monies

raised in this manner shall be utilized towards furthering the objectives of the Trust.

- (9) To appoint a Committee/Committees of management for such terms and with such powers as may be specified from time to time, for carrying on the routine management of the affairs of the Trust.
- (10) To appoint such employees on such terms and conditions as the Trustees may deem fit for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal from service or any other disciplinary action as deemed appropriate in terms of the terms and conditions of the employment of the said employees.
- (11) To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- (12) To frame Byelaws and such other regulations as are required for achieving its objectives.
- (13) Out of the income of the trust property the trustee shall be entitled to spend or incur the following expenses namely:
- a) All rates, taxes, cess, assessments, dues and duties if any payable to the government to any municipal or other public bodies in respect thereof or any part thereof.
 - b) The premium for the insurance of the buildings or any other insurable property movable or immovable for the time being forming part of the trust property.
 - c) The costs of ordinary repairs and for providing any amenities to the buildings for the time being forming part of the trust property.

- d) The cost of making such additions/alterations or improvements to or in the buildings forming part of the trust property, as the trustees shall think fit.
 - e) Wages and salaries of any manager, supervisor, accountant, clerk, servant or other employees employed by the trustees in the carrying out of this trust.
 - f) Cost and expenses of keeping the trust property in good condition.
 - g) Cost and expenses for installing and renovating the electrical and other installations in the building for the time being forming part of the trust property.
 - h) The architect's fee and legal charges and fee payable to other professionals including Chartered Accountants appointed for auditing the accounts of the Trust, engaged in the course of administration of the trust.
 - i) All other costs, charges and expenses of and incidental to the management and administration of the trust property in accordance with the objects and purposes hereof or which may be incidental thereto.
- (14) The trustees shall have no right or powers to act beyond or in violation of the objectives of the trust mentioned hereinbefore.
- (15) No portion of the trust funds, assets and properties both moveable & immovable shall be advanced to or kept in deposit with any of the Trustees and/or their respective firm, company or association of persons in which any of the Trustees or their Spouses, sons, daughters-in-law, sons-in law and/or grandsons and granddaughters are involved.
- (16) In case at any time for any reason the funds or income of the trust become so meagre or insufficient that after due deliberations it is found difficult to meet recurring expense of any institution run by trust, the trustees may run it on a

smaller scale or close the same or any section/department thereof. In the event of the trustees deciding to close down all its institutions/centres/activities undertaken and/or in the event of the dissolution of the trust hereby created the trustees shall after paying off all liabilities of the trust out of the assets in hand and make over the balance, if any, to any such trust or organization or society having similar objectives, as may be decided by the trustees. In no case, shall the balance be handed over to all or any Settlor and/or Trustees, and/or donors and/or relatives or heirs thereto.

After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the objects of the trust as decided by the board of trustees.

15. BOOKS OF ACCOUNTS

- i. The board of Trustees may open such Bank Account or Account in any of the Nationalised Banks including the State Bank of India and its Associates and/or Private Sector Banks in the name of **MAA LAKSHMI FOUNDATION** such Bank Account or Accounts shall be jointly operated by the Chairman and Managing Trustee.
- ii. The trust may open Bank Account/s in the name of institution/organisation founded by the Trust. Such persons as authorized by the board of trustees shall operate such Bank accounts from time to time.

16. APPLICATION OF THE PROPERTIES OF THE TRUST

The properties and funds of the Trust shall be applied only for the purpose of the Trust and for the due administration of its business affairs and properties provided, however, that this shall not preclude payment of any reasonable remuneration or allowance or giving of residential accommodation or any perquisites to any trustee in

connection with the work carried out by him/her for the purpose of the Trust.

17.ACCOUNTS

The Trustees shall maintain a true and correct record of the receipts, payments income and expense and transactions of the Trust. A qualified auditor or a Chartered Accountant appointed by the Board of Trustees shall audit the Books of account of the trust every financial year i.e., commencing from 1st April to the 31st March of Next year.

18.DEFECTS OF PROCEDURE IMMATERIAL

No act of trustees with full quorum shall be invalidated by reason only on account of any vacancy in the Board of Trustees or any procedural irregularity in the proceedings of the Board of Trustees or any Committee thereof provided that the act is taken in good faith, without mala fide and negligence.

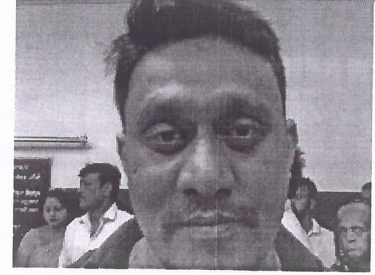

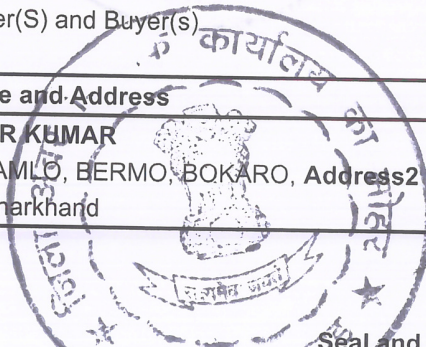

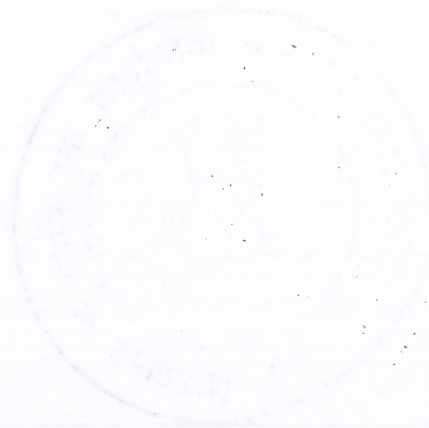
